Body text must be double-spaced. Font must be Times New Roman or a similar serif font, and 12 point. Footnotes may be 10 point and single-spaced, but there should be a space between notes. Citations must conform to the 21st Ed. of The Bluebook. The author's name should NOT appear anywhere on the paper. Only one entry will be accepted per student or student co-authors.
